## **NORTH GAZA GOVERNORATE**

North Gaza Branch & EMS center endured significant destruction. They moved their operations to a temporary location inside Jabalia refugee camp.

- Advanced Medical Post is operational since 20/11/2023.
- 2 ambulances are operational

## **GAZA GOVERNORATE**

Gaza Branch, EMS center & Al Quds Hospital are still not operational since 14/11/2023.

## **CENTRAL GOVERNORATE**

- EMS & relief teams are operational 24/7.
- PHC services are provided.
- 30 displaced families are hosted at the branch.
- 1 IDPs camp host 51 families.
- 2 Medical points

## KHAN YOUNIS GOVERNORATE

Khan Younis Branch, EMS center & its other service centers, & Al Amal Hospital endured significant damages due to the continuous shelling.

After 42 days of siege, the Israeli force withdrew from Al Amal area where PRCS is located on 3/3/2024.

## RAFAH GOVERNORATE

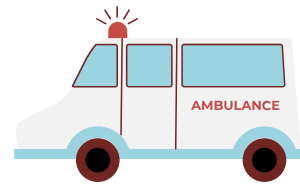
- EMS & relief teams are operational 24/7.
- Al Quds medical post is operational since the start of February 2024.
- Medical services through 3 medical points distributed on various locations in the governorate.
- 3 IDPs camps host 196 families.
- Aid consignments are received, processed & distributed

**17,613** injured persons received first aid services & **5948** fatalities were evacuated by PRCS teams.

**56,527** individuals benefiting from psycho social support activities.

These services are being offered across the displacement camps established by PRCS, at their medical posts, as well as in shelters managed by UNRWA.

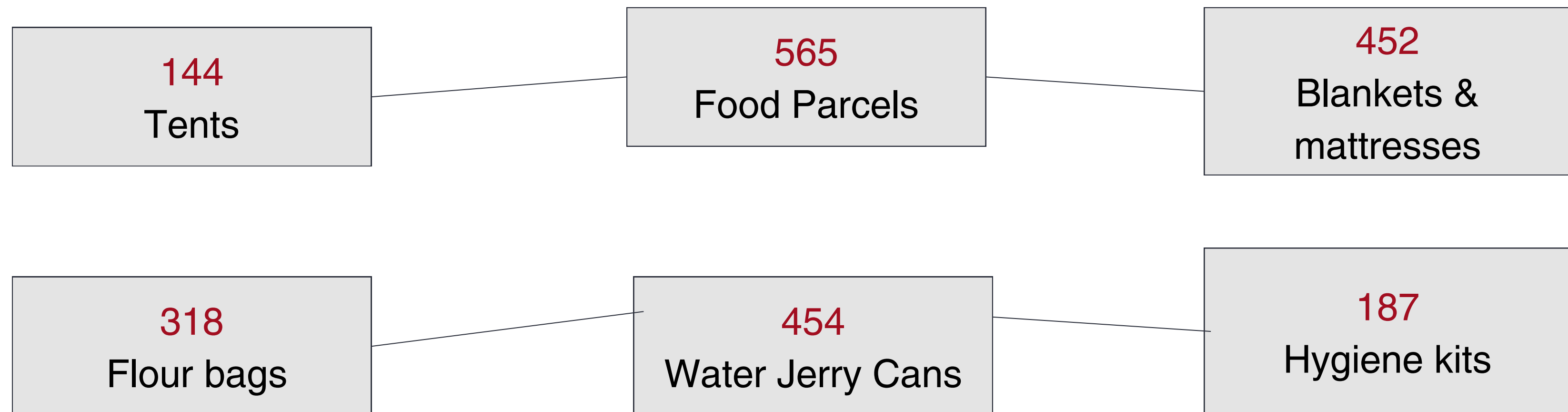

# Emergency Appeal:

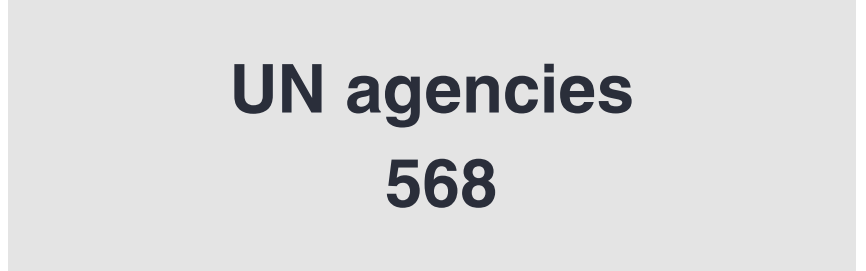
- To respond to the increasing humanitarian needs arising from the Israeli aggression on the Gaza Strip, the PRCS launched its second revised emergency appeal on 12/12/2023.



- **The appeal sought \$ 298,736,550** in funds from partners and supporters within the international Movement of the RCRC, non movement as well as local & international entities.
- As of 10\3\2024, contributions from a variety of national societies, international organizations, and the private sector **have fulfilled 15.02% of the requested cash funds.**

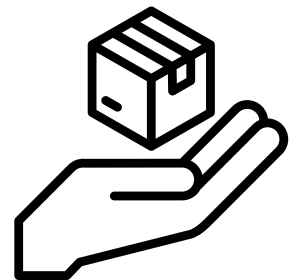
